**2010 BOARDS AND COMMITTEES – PUBLIC VACANCIES**

City Council invites persons wishing to serve as a member of the following Boards and Committees to submit an application to the City Clerk:

**Financial Advisory Committee**

A committee comprised of members of the public and members of City Council who review and report to Council on financial matters of the City, such as contractual labour obligations, reserves and trust funds, investment policies, long term financial planning, capital funding strategy, capital expenditures, general financial reporting policy, performance measures, Provincial/Federal grants, auditors and insurance coverage.

- *1 position for a 3 year term – expiring January 31, 2013*

**Festival of Northern Lights**

A committee comprised of members of the public and members of City Council who develop, promote, implement, maintain and evaluate an annual display of Christmas lights for the City of Owen Sound.

- *1 position for a 1 year term – expiring January 31, 2011*
- *1 position for a 2 year term – expiring January 31, 2012*
- *5 positions for a 3 year term – expiring January 31, 2013*

**Recreation and Parks Advisory Committee**

A committee comprised of members of the public and members of City Council who advise Council on policy matters relating to the provision of recreation services and parks development, use, maintenance and related services.

- *2 positions for a 3 year term – expiring January 31, 2013*

## **Community Planning and Heritage Advisory Committee**

A committee comprised of members of the public and members of City Council who provide recommendations suitability of development projects proposed for the City, assess the merits of Official Plan and Zoning By-law amendments, monitor the City's Policies relating to land use planning and to provide recommendations to Council on improvements. To provide advice and recommendations and education to Council on heritage planning and all matters related to built heritage resources and significant cultural heritage landscapes.

- *1 position for a 2 year term – expiring January 31, 2012*
- *2 positions for a 3 year term – expiring January 31, 2013*

## **Operations Advisory Committee**

A committee comprised of members of the public and members of City Council who advise Council on policy matters related to the maintenance of the City's built infrastructure, including roads, in-ground services, parks, and equipment management. This committee advises Council on the establishment of community safety zones in the City of Owen Sound where traffic and safety is of particular concern.

- *1 position for a 2 year term – expiring January 31, 2012*
- *2 positions for a 3 year term – expiring January 31, 2013*

## **Accessibility Advisory Committee**

A committee comprised of qualified members of the public and members of City Council who provide advice to Council on the preparation, implementation and effectiveness of its accessibility plan. This committee also provides advice on the accessibility for persons with disabilities to a building, structure or premises, or part of a building, structure or premises and reviews site plans in a timely manner.

- *2 positions for a 2 year term – expiring January 31, 2012*
- *2 positions for a 3 year term – expiring January 31, 2013*  
*(3 must be qualified)*

## **Cultural Advisory Committee**

A committee comprised of members of the public and members of Council who develop partnerships to support and promote the City and its cultural events, local attractions, entrepreneurs and non-profit groups that develop cultural and eco-tourism initiatives and advises Council on policy matters relating to the provision of culture and related services.

- *1 position for a 3 year term – expiring January 31, 2013*

## **Environmental and Waste Advisory Committee**

A committee comprised of members of the public and members of City Council who establish, revise and review City policy regarding waste management to achieve better diversion of waste and promotion of recycling.

- *1 position for a 3 year term – expiring January 31, 2013*

## **Economic Development Advisory Committee**

A committee comprised of members of the public and members of City Council who support and foster a positive economic environment enabling businesses of all sizes to thrive. This includes marketing and promoting the community, conducting research and analysis and visiting local businesses. A tourism information centre also supports the information needs of all interested visitors and new residence.

- *3 positions for a 1 year term – expiring January 31, 2011*
- *3 positions for a 2 year term – expiring January 31, 2012*
- *4 positions for a 3 year term – expiring January 31, 2013*

## **Downtown Improvement Area Board of Management**

A board comprised of members of the Downtown Improvement Area and member of City Council who oversee the management, representation, revitalization and organization of the downtown core.

- *2 positions for a 1 year term – expiring November 30, 2010  
(due to increased membership)*

## **Tom Thomson Art Gallery Board**

A board comprised of members of the public and members of City Council who assist with the operation and management of observatories of works of art including a permanent collection.

- *1 position for a 1 year term – expiring January 31, 2011  
(due to resignation)*
